Opening:	Dr Robinson opened the meeting with prayer after which she handed over to Alan Danson who welcomed everyone to the meeting.

1. Minute of the Fifty Second Meeting held on Wednesday 5th September 2018

The Minute of the Fifty Second meeting of the Joint Vestry held on Wednesday 5^{th} September 2018, was unanimously adopted as a true and accurate record of that meeting.

2. Matters Arising:

3. Correspondence:

- a) All relevant correspondence had been circulated to the Vestry. All other correspondence of a routine nature had been dealt with by the Secretary.
- 4. **Finance Report**: The Treasurer, Peter Furniss, submitted the following report.
- 1. <u>Statements of Account for the year ended 30 September 2018</u>

Two Schedules are attached for consideration showing our day to day income and expenditure. The key figures are:

Income for the year	£67,149.87
Expenditure for the year	£67,096.94

Surplus

The results are slightly better than I indicated at the last meeting largely because of the timing of certain transactions.

In addition to the above there are Restricted Funds income transactions during the year relating to a National Insurance Refund totalling £5,313 together with Grants and Donations totalling £9,560 all relating to the Arpafeelie Project.

The overall Bank Balance at 30 September 2018 was £31,547.99. This includes monies recently received for the Arpafeelie Project, together with other restricted monies. totalling £25,794.99. The remaining £5,753 is money available for day to day activities.

2. Income

I reported to the previous meeting that this year we have benefitted from two windfalls courtesy of HMRC; namely: Additional gift aid on cash collections totalling £3,922.76, and A refund of Employers National Insurance amounting to £7,101.48 These have used to help defray the cost of replacing the heating boiler at St Andrews and to support the Arpafeelie Road to the extent of £5,313

There will be some additional benefit in future years from extra gift aid and lower national insurance, but nothing like to the same extent and, as previously mentioned, I will be reporting at the AGM that there is a need for congregations to increase their regular donations to help defray our ever-rising costs.

3. <u>Expenditure</u>

In terms of expenditure, compared to last year there have been increases in insurance, heating and lighting (primarily electricity costs) and Church Purchases (new cassocks). The need for the boiler replacement at St Andrews has fortunately been offset by lower expenditure this year in other maintenance areas. Overall our costs are about £3,800 more than last year.
